European App Competition

The Dutch Presidency of the Council of the European Union and Open State Foundation also organised an [app competition](#) in the run up to TransparencyCamp Europe. As part of the competition, several hackathons (diplohacks) were organised by Dutch embassies in various [European capitals](#).

Civic hackers used European open data to create new apps for European citizens. These tools help to provide easy access to EU and national government information by presenting information in places where people are looking for it, whether online or on their mobile devices. The winners of all these competitions will present their apps at TransparencyCamp Europe.
