## Elinvar successfully completes funding round with Goldman Sachs as lead investor

BERLIN – May 15, 2019 As part of its latest funding round, Elinvar, the digital platform for asset and wealth managers, expands its shareholder base. The Goldman Sachs Principal Strategic Investments group was lead investor for the investment round (subject to approval of BaFin, the federal office for financial supervision). Existing shareholders, Ampega Asset Management and finleap contributed to the round as well. Elinvar's total funding has thereby risen to more than € 20 mio.

Founded in summer 2016 in Berlin, Elinvar is the digital platform for asset and wealth managers. It exclusively focuses on B2B2C, enabling its partners to digitalize their business models. Elinvar combines technological expertise with the optimal regulatory setup, holding all necessary BaFin licenses. Several major German private banks and discretionary portfolio managers are already using the digital platform; among them: Privatbank Donner & Reuschel, Fürstlich Castell'sche Privatbank and M.M.Warburg & CO. Within less than three years, Elinvar has grown to 80 employees.

Its two existing investors Ampega Asset Management (Talanx Group) and finleap both contributed to the round again, which was led by the Goldman Sachs Principal Strategic Investments group (subject to approval of BaFin, the federal office for financial supervision).

Elinvar will use the investment to further grow its team in a lean and sustainable manner, while focusing on its core competency: providing the optimal digital platform for asset and wealth managers. The new shareholder structure will help Elinvar to internationalize by expanding its offer to further European countries.
