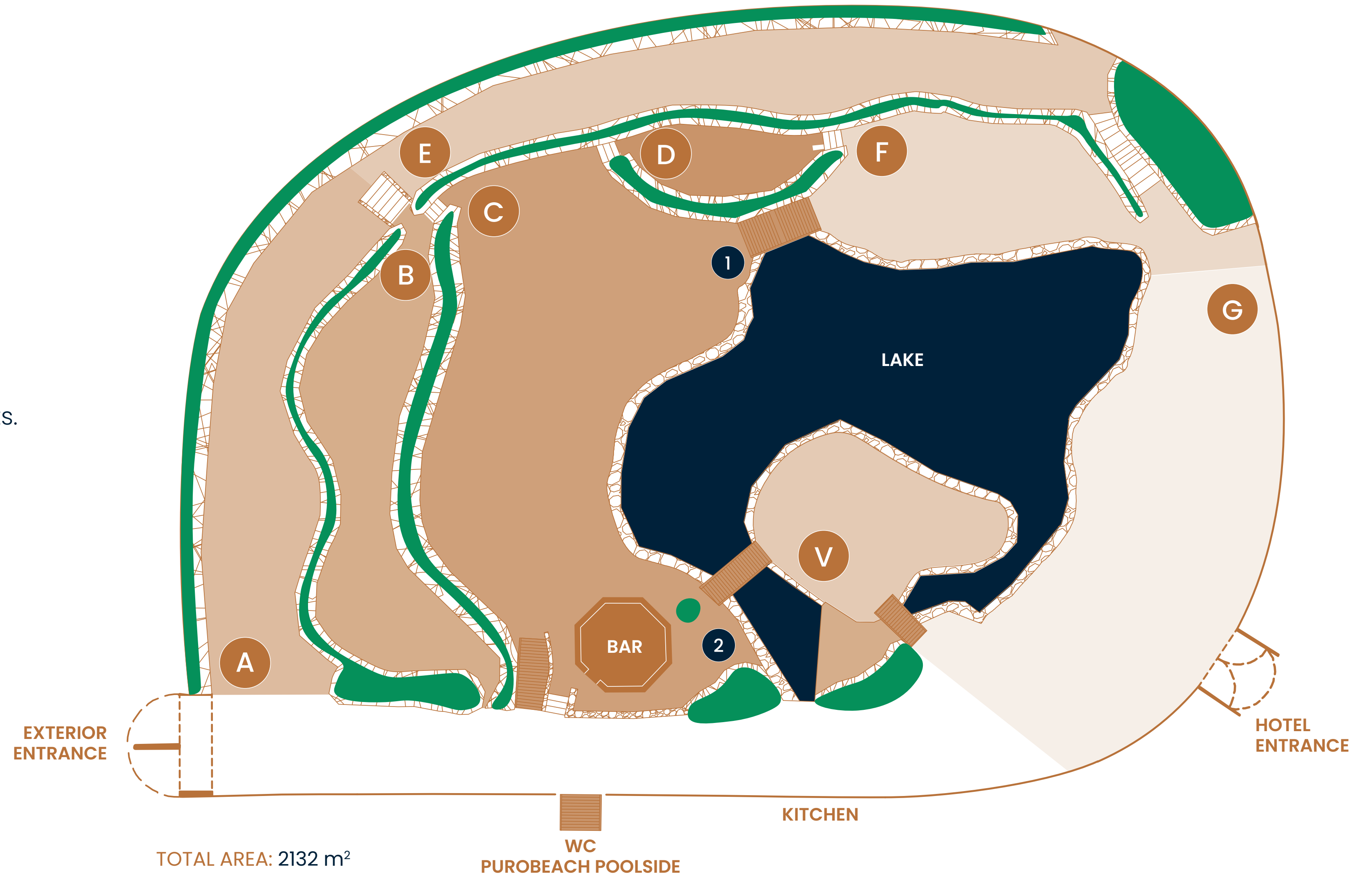

TECHNICAL SPECIFICATIONS

1 – LICENCING

Music is allowed at Lakeside until midnight, with possibility for extension until 2:00, according to additional sound licensing approval.

License request should be shared with the hotel up to 2 months prior the event, including the identification of performers (musicians, etc.) and type of equipment.

When authorized by the city hall, this license states that legal noise limits must be respected, safeguarding the right of the neighbours to rest, as per Portuguese law “art. 11º of dec.-law nº9/2007 of 17th January”.

The presence of the authorities due to complaints may lead to the full stop of the sound/music.

2 – SOUND POWER / DECIBELS

City Hall allows up to 82 decibels at Lakeside, subject to license approval.

All equipment must be connected to the hotel sound limiter equipment, as this is compulsory by law. In the case of live bands, all instruments and sound equipment (excluding acoustic instruments) must be connected to the hotel sound limiter equipment. Three-phase Electric Power: 125 AMP

3 – SPEAKERS / ORIENTATION

All sound system must be oriented towards the sea and ground. Subwoofers can only be placed on the lower floor / dance floor, facing the sea and also connected to the sound limiter.

4 – RESPONSABILITY / AUTONOMY

The hotel has the right to lower the volume in case of a serious noise complaint.

TERMS AND CONDITIONS

1 – PRICES

The presented prices are per person, minimum 100 guests and maximum 786 guests for Buffet or 930 guests for Set Menu. Prices can be modified anytime without prior notice and are subject to change due to any variation in, or imposition of government taxes, charges or levies.

In case of need of extra service hours, there will be an extra charge of € 400 per hour until midnight. After midnight an extra charge of € 5 per person per hour will be applied. The presented menus are valid only in Lakeside.

The stated prices and conditions are applicable for events held in 2024.

2 – PRICES INCLUDE

1/2 bottle of wine per person.

2 hours service.

Legal taxes.

Complimentary parking (subject to availability).

Direct access from outside with parking for cars and buses.

Direct access from outside for trucks for loading and unloading.

Ramp access and bathrooms for clients with reduced mobility.

3 – NOT INCLUDED

Excludes air conditioning system. Sound system. Entertainment. Cloakroom service. Table centre piece decorations.

4 – FOOD AND BEVERAGE POLICY

For hygiene and food safety reasons, no food nor beverages of any kind will be permitted to be brought onto the premises by the patrons or any of the patron's guests or invitees, without special permission from the hotel. The hotel reserves the right to make a charge for the service of such food and beverage.

5 – CONFIRMATION OF MENU AND NUMBER OF GUEST

Final guest numbers are required 15 working days prior of the reception and they will be the minimum numbers charged for. Should the numbers decrease on the day of the function, the original confirmed numbers given stands. Any increase in the numbers attending will be charged accordingly. Full menu details are required 15 days prior to the event.

6 – FOOD RESTRICTIONS, ALLERGIES AND ETHNIC FOOD

Please inform us in the time of booking, in case of any food restrictions, allergies or preferences for ethnic food.

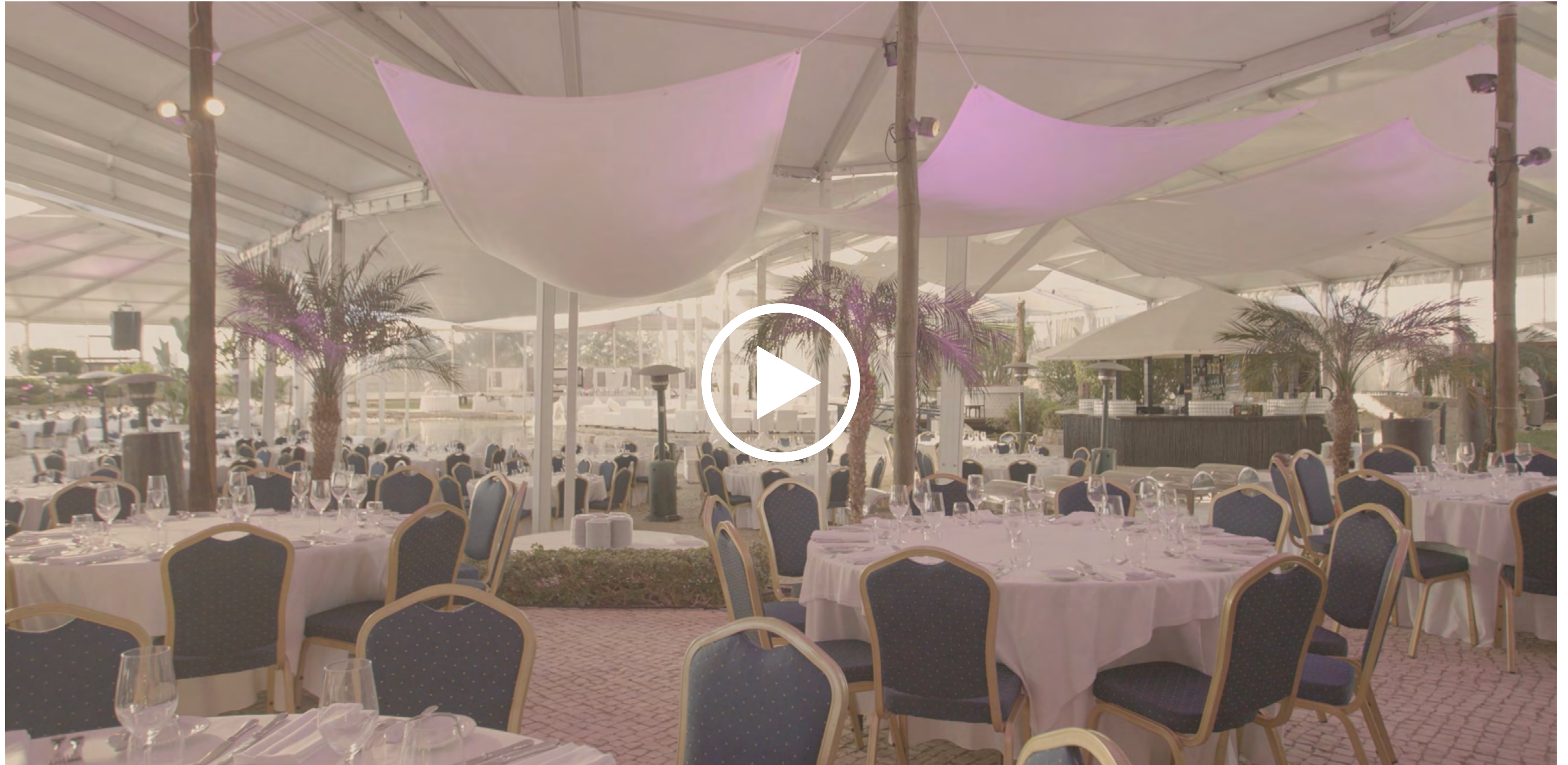
7 – EVENT TIMES
